



## NOTE

With reference to the change of personal data protection laws and the entrance into force of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, **GDPR**) on 25 May 2018, **please be informed that:**

1. The Data Controller of your personal data is Global Control 5 sp. z o.o. with registered office in Warsaw (postcode 02-820), at ul. Wyczółki 71 (hereinafter referred to as the "Data Controller").
2. We process your personal data based on Article 6(1)(b) of GDPR for the purpose of executing an employment contract and based on Article 6(1)(c) of GDPR for the purpose of performing legal obligations relating to the employment, while the legal basis for processing the data are:
  - a. The Labour Code Act of 16 June 1974 (Journal of Laws 1974.24.141, as amended);
  - b. The Social Insurance System Act of 13 October 1998 (Journal of Laws 1998.137.887, as amended);
  - c. The Personal Income Tax Act of 26 July 1991 (Journal of Laws 1991.80.350, as amended);
3. The personal data we process include name, surname, telephone number, address of current/permanent residence, PESEL number, ID card number, parents' names and surnames, children's names and surnames, and other data you have provided.
4. Your personal data may be handed over to:
  - a) Providers of services, especially IT or legal services, who are required to comply with the personal data protection laws;
  - b) Our employees in relation to the performance of their work duties;
  - c) Other entities or state authorities, provided that the disclosure of your personal data is required by law.
5. Your personal data may be transferred to the United States of America in relation to the IT services provided for the Data Controller based on the decision of the European Commission specifying the proper data protection level, as set forth in Article 45(1) of GDPR, and to other countries as required by the processing purpose.
6. You have the right to obtain, based on a written request, a copy of the personal data transferred to third countries and information on what measures have been taken to secure the data.
7. Your personal data will be stored for 50 years from the employment contract expiration date.
8. You have the right to access your personal data, have them rectified, removed or have their processing restricted, and object to their processing or transferring.

12. You provide your personal data voluntarily, although this is necessary to execute a contract as required by law. A failure to provide personal data means that it is impossible to execute an employment contract or perform it properly.
